We will search for **one item only**, this may include the following:

- an entry in a parish register
- an entry in an electoral register (excluding previous 10 years)
- memorial inscription
- an entry from a website such as Ancestry or Midlands Historical Data
- a name in a deed
- a specific report in a newspaper
- an entry in a vehicle license register
- an entry in a trade directory

In all cases you must supply specific information to guide the search, names, places, dates, reference numbers as appropriate. If you have none of these then you will need to use the full research service.

The cost for this service is **£7.50p** by cheque (made payable to Warwickshire County Council) or **£10.00** by credit card to incorporate the additional administrative charge. The price will include the cost of a copy where this is applicable ie a reader printer copy from a parish register or a document that can be photocopied. It would not include the cost of scanning or digital photography.

Some items cannot be searched in this way for example more recent or sensitive records may have issues relating to Freedom of Information or Data Protection. If this is the case you will be advised accordingly.

There will be **no refund** where a search has proved unsuccessful as you are paying for the staff time to undertake the search.
